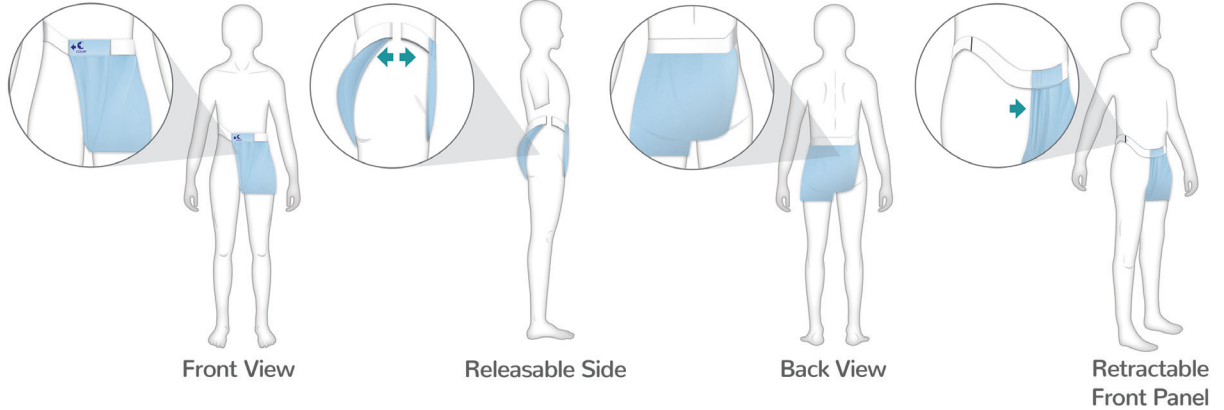
### Features:

### Reversible - Turn Inside-out

- Packaged for right-sided procedures
- For left-sided procedures turn garment inside-out

For medical and surgical procedures requiring access to either Left or Right hip, pelvis and groin regions. For example: Venous Ultrasound/Ablations, Vascular Surgery, Total Hip Arthroplasty, Hip Arthroscopy, Hip Injections/Aspirations, MR Arthrograms, Hip Fractures, Pediatric Surgery, Total Knee Arthroplasty, and many other procedures that require access to one side (Left or Right)

## BILATERAL

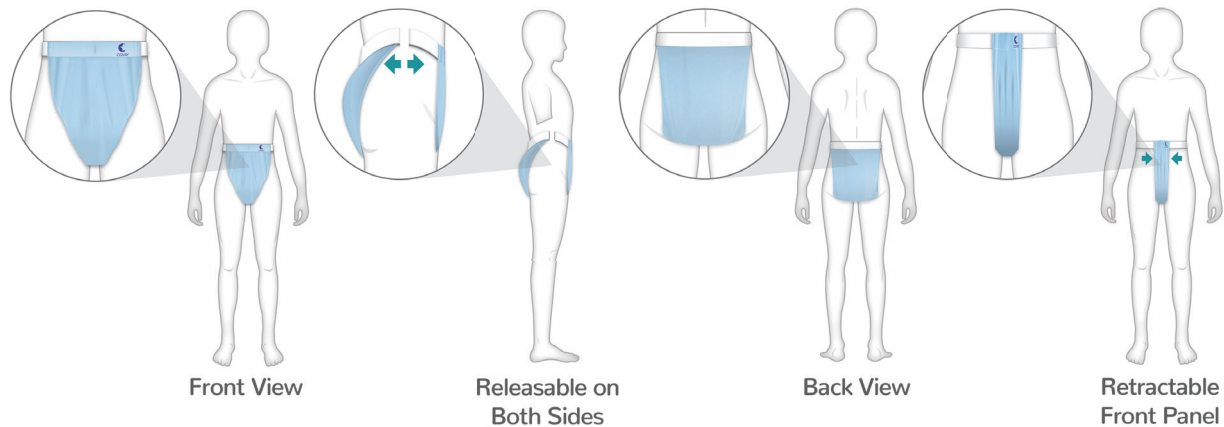
### Features:

A retractable front panel and a releasable waistband on both sides for patient preparation and more procedural access

Full coverage – front and back

Bilateral access to the hip and groin regions

## RETRACTABLE, RELEASABLE



For medical and surgical procedures requiring access to both Left and Right hip, pelvis and groin regions. For example: Cath Lab, Interventional Radiology, Venous Ultrasound/Ablation and Vascular Surgery. This product is also used in departments such as Pediatrics, Plastic/Reconstructive Surgery, G.I. Colonoscopy, Gynecology, Urology and many other procedures that requires access to the patient's private areas or to both sides (Left and Right)
